FINANCIAL INFORMATION

Federal Stafford Loans will be awarded to all eligible students for the full cost of tuition and fees for the year, unless requested otherwise. Additionally, students may be eligible to borrow funds to pay for other educational expenses. The maximum eligibility for Subsidized Stafford Loans is \$8,500 per year, and the maximum eligibility for Unsubsidized Stafford Loans is \$12,000 per year, for a total of \$20,500. If you would like to borrow funds for additional educational expenses, please indicate below the amount for full academic year. These funds are only available pending final eligibility. Funds for additional educational expenses will not be disbursed to the student until all necessary documentation has been received by the Office of Financial Aid and a refund request submitted to the Cashier's office. The first date that these funds will be available for the fall semester will be *September 24*.

 - Copies of all 2007 W-2s for the student (and spouse, if applicable)
